Brown Act: This meeting abides by Cal. Gov't Code § 54953.

Cal. Gov't Code § 54953(b)(1) "Notwithstanding any other provision of law, the legislative body of a local agency may use teleconferencing for the benefit of the public and the legislative body of a local agency in connection with any meeting or proceeding authorized by law. The teleconferenced meeting or proceeding shall comply with all otherwise applicable requirements of this chapter and all otherwise applicable provisions of law relating to a specific type of meeting or proceeding."

Cal. Gov't Code § 54953(j)(6) A "teleconference" is "a meeting of a legislative body, the members of which are in different locations, connected by electronic means, through either audio or video, or both."

Gov't Code § 54953 (b)(2) "Teleconferencing, as authorized by this section, may be used for all purposes in connection with any meeting within the subject matter jurisdiction of the legislative body. If the legislative body of a local agency elects to use teleconferencing, the legislative body of a local agency shall comply with all of the following:

(A) All votes taken during a teleconferenced meeting shall be by rollcall.

(B) The teleconferenced meetings shall be conducted in a manner that protects the statutory and constitutional rights of the parties or the public appearing before the legislative body of a local agency.

(C) The legislative body shall give notice of the meeting and post agendas as otherwise required by this chapter.

(D) The legislative body shall allow members of the public to access the meeting and the agenda shall provide an opportunity for members of the public to address the legislative body directly pursuant to Section 54954.3."

Gov't Code § 54953 (3) "If the legislative body of a local agency elects to use teleconferencing, it shall post agendas at all teleconference locations. Each teleconference location shall be identified in the notice and agenda of the meeting or proceeding, and each teleconference location shall be accessible to the public. During the teleconference, at least a quorum of the members of the legislative body shall participate from locations within the boundaries of the territory over which the local agency exercises jurisdiction, except as provided in subdivisions (d) and (e)."

Background

The Silicon Valley Library System, (previously known as the South Bay Cooperative Library System) was established through a JPA document from 1975, with an update from 1985.

The SVLS Council most recently updated the Bylaws in 2019. The Bylaws identify two levels of membership:

Section 1: Full Membership

Full membership status of SVLS will be limited to those libraries that are officially accepted and recognized as members by the California Library Services Board, having met the requirements set forth in the California Education Code, Sections 18700-18767 (California Library Services Act Regulations), and Code of California Regulations, Sections 20100-20236.

Section 2: Associate Membership

- A. Associate membership status will be limited to those non-public libraries in the Santa Clara County which meet the definition of 'library' as defined in the California Educational Code, Title 1, Division 1.
- B. Associate members do not hold voting rights on SVLS matters.
- C. Per the California Library Services Act Regulations, no associate member that is not a public library may benefit from the funds which SVLS may receive which come from the California Library Services Board.

At this time, the current members of SVLS are public libraries, as full members.

Within two other regions of the Pacific Library Partnership, the Monterey Bay Area Cooperative (MOBAC) and the Peninsula Library System (PLS), there are community colleges, special libraries, and universities which belong to the regional systems. The Bay Area Library and Information Services (BALIS) does not have any non-public libraries.

Discussion

The West Valley Community College District, which is located in Santa Clara County and includes the West Valley and Mission Community Colleges, has reached out to express preliminary interest in joining SVLS, and, by default, PLP.

As you may recall, PLP is a JPA of JPA's, meaning, no individual library belongs to PLP. The four regions (MOBAC, SVLS, PLS, and BALIS) belong to PLP.

Although non-public libraries cannot participate in California Library Services Act funds, they can benefit in other ways, as most of their faculty and students are also being served by the public libraries. Those benefits include attending the regional meetings, resource sharing, the possibility for shared courier services, and access to PLP services such as the innovation grants and staff development.

There are no dues to be a member of SVLS. Libraries are members of PLP, and as such, pay membership dues to PLP. The dues for academic and non-public institutions are on a different scale than public libraries.

The SVLS Bylaws and JPA documents mention that a condition for library membership is to "libraries that are officially accepted and recognized as members by the California Library Services Board, having met the requirement set forth in the California Education Code, Section 18700 – 18766..." One of those "requirements" is that the member library must provide equal access to all residents of the system to which it belongs. The documents are silent about timing for joining. Typically, for the libraries which have joined and left the various systems, this occurred at the beginning of a fiscal year, although partial pro-rated membership has occurred.

The process for approval of a member would be for it to be approved by the SVLS Council, and then the PLP Executive Committee.

Recommendation

No action is required at this time. The SVLS Council should be familiar with their governing documents should the West Valley Community College District request to join SVLS, and, by default, PLP.
