**I. Call to Order and Introductions**

The meeting was called to order at 10:05 a.m. by Chair Kanth.

**II. Approval of Consent Items****A. Adoption of Agenda****B. Approval of the October 7, 2024 Minutes**

A motion was made, and passed unanimously, to approve the Consent Items. (M/S Bourne/Weeks)

**III. Old Business****A. Dolly Parton Imagination Library**

Weeks reported that the Santa Clara County Library District Foundation has secured funding to support the Dolly Parton Imagination Library (DPIL) for Santa Clara County children ages 0-5. The Library District will be providing the administrative support starting in the fall. She asked that other SVLS directors let her know which staff member at their libraries would be the contact point for DPIL activities. Weeks stated the Los Altos Rotary Club was taking the lead to encourage other Santa Clara County Rotary Clubs' involvement. Wong asked how many people the funding will cover. Weeks answered, it should be enough to cover two- or three-years' worth of participants. Bourne noted this program could align with SJPL's "read by 3rd grade" initiative. Wong asked if DPIL would be okay with being included in other programs or if they required promotion to be stand alone. Weeks agreed to inquire with DPIL to make sure that is allowable.

**IV. New Business****A. Review of SVLS Bylaws and Membership Levels (West Valley Community College Interest)**

Wasterlain described an email received from Joanna Messer, Director of Library and Learning Support Services at West Valley Community College, expressing interest in joining SVLS. Wasterlain noted that Messer was previously the director of Cabrillo Community College Library and an active member of the Monterey Bay Area

Cooperative Library System. He mentioned West Valley Community College and Mission College in Santa Clara are connected organizations, so both colleges would likely become members. The Council was excited about the potential of including these two colleges. Wasterlain stated he would contact Messer and John Schoppert (Mission College) to meet with the Council in October to further discuss the potential of them joining SVLS.

**B. Piggyback Contract Discussion**

Weeks asked if directors could inform each other of RFPs their organizations have done in case there are chances to piggyback on each other's contracts. Wong noted this is often better for the vendors as well as the libraries since they don't need to spend resources applying for the RFP multiple times. Wong asked if there might be a way of collecting RFPs from across PLP in a clearinghouse manner for libraries to have access to. Wasterlain noted there was a previous website that did something similar statewide, but he was unsure what the status of it is. He stated he would explore the possibility.

Weeks reported she and Bourne were meeting with Reid Myers to plan for next year's program. She noted the kickoff date in January would be finalized soon.


# Restore California Library Services Act Funding to Public Libraries



Public libraries are trusted spaces for information, community gathering, and connection. California Library Services Act (CLSA) funds support libraries as **building blocks for community and economic development**. They help job seekers, teach English-language learners, and build literacy skills for children and adults.<sup>1</sup>

Libraries are stronger when they work together. CLSA funds enable library cooperatives to **share millions of books and electronic materials** in both rural and urban communities, saving taxpayer money. CLSA funds also provide critical funding to **support internet access** in rural libraries.

**CLSA Funds have decreased from a high of \$6.6M in 2016-17 to \$1.8M in 2025-26:**<sup>2</sup>



**Libraries are at a tipping point.** CLSA funds now stand at \$1.8 million or just 5 cents per person in California. While state funds are cut, service costs rise 5% annually, federal funding to libraries is under threat, and libraries are cutting services.

## Our Ask:

Please write a letter of support for the restoration of CLSA funds for public libraries to \$5M to be included in the January 2026 Preliminary Budget.



“San Leandro Public Library uses CLSA funds for LINK+, which **helps us provide for the underserved by connecting users to materials** the library simply cannot buy because of its size.”

“Downloadable digital books continue to be an important resource in Santa Cruz County, **especially for seniors who live in part of the County not immediately served by a library branch**. Materials in Spanish help local immigrant populations who have limited English reading skills.”

<sup>2</sup> Values reflect funding distributed as local assistance to the nine library cooperative systems and do not reflect \$1M in Zip Books funding administered by the State Library that was added to the budget in 2021.

# Pacific Library Partnership and California Library Services Act Funding

CLSA funds go to the nine library cooperatives statewide, including the Pacific Library Partnership (PLP). **The Pacific Library Partnership (PLP) serves 43 public and community college member libraries and 7,102,693 Californians in 8 counties.**



PLP's mission is to empower member libraries through **innovation, collaboration, and training**.

- 23 libraries are small or rural with budgets below \$10M
- 44% of our communities are non-English speaking
- 14% of our communities are economically disadvantaged

PLP received **\$367,803** in CLSA funds in FY 24-25, or **5 cents per capita**. Funds go directly to libraries for resource sharing that best suits their community needs.

## How did PLP libraries use CLSA funds in 2024-2025?



Courier services **traveled over 102,000 miles to deliver 2.5+ million books** and other materials among libraries, ensuring residents in rural and isolated areas have access to library collections.



**2,900 eBooks and eAudiobooks purchased in multiple languages** so patrons can access materials in their preferred language. These shared materials were used nearly 40,000 times.



**117,000 items loaned and 96,000 borrowed** among libraries through Link+, a wider lending network across California and Nevada.



**eMagazines were available** to 8 library communities with the most limited budgets. This service is being cut due to continued CLSA reductions.



The smallest member library, with an annual budget of \$60K, used CLSA funds to **provide access to the internet**.

### **Background**

Silicon Valley Reads has been offering the One Book, One Community program since 2003. The Silicon Valley Library System Administrative Council has financially supported this event by annually allocating \$5,000.

At the October 7, 2024, meeting, the Council approved allocating \$5,000 to Silicon Valley Reads' 2025 program.

The 2026 Silicon Valley Reads theme and book titles has not been publicly announced yet, but information will be released soon.

### ***Recommendation***

SVLS has used the SVLS Fund Balance to contribute towards Silicon Valley Reads. The current Fund Balance is \$111,257.

It is recommended that the SVLS Administrative Council consider and approve the use of \$5,000 of SVLS Fund Balance to support the 2026 Silicon Valley Reads.
